

**NOTICE OF A PUBLIC HEARING

and ON BEHALF OF BROWN, DERRY AND GRANVILLE TOWNSHIP  
SUPERVISORS AND LEWISTOWN BOROUGH COUNCIL  
FOR THE BUDGET MODIFICATION TO FEDERAL FISCAL YEAR 2020  
COMMUNITY DEVELOPMENT BLOCK GRANT – CARES ACT (CDBG-CV) PROGRAM**

Notice is hereby given that the Mifflin County Commissioners and on the behalf of Brown, Derry and Granville Townships, and Lewistown Borough, plan discuss proposed modifications for Mifflin County Federal Fiscal Year (FFY) 2020 CDBG-CV program. The proposed changes include the reduction of the Laptop Devices for Mifflin County Students Fair Share Project and the addition of the NuVisions Senior Net Program Equipment Fair Share project in the amounts as listed below, and the addition of the Menno Township Swing Set Project in the amount of \$8,866.50. All previously approved 2020 CDBG-CV projects adopted by the Mifflin county Commissioners by Resolution remain in full force and effect.
