

**First Public Hearing Notice for  
Mifflin County and on Behalf of  
The Armagh, Brown, Derry and Granville Township Supervisors  
and the Lewistown Borough Council  
For the Federal Fiscal Year (FFY) 2023 Community Development Block Grant (CDBG) Program**

Notice is hereby given that the Mifflin County Commissioners plan to submit an application to the Pennsylvania Department of Community and Economic Development (DCED) for Federal Community Development Block Grant (CDBG) funds. The County has not been informed as to the amount of its FFY 2023 allocation nor the deadline to submit the application. Anticipated funding allocations based on FFY 2022 allocations are listed below. The application to DCED is expected to be due in the fall of 2023.

The County will consider applying for Competitive CDBG funds for municipalities and projects that meet all of the competitive program criteria set forth by DCED. Applications must be a minimum of \$100,000 with no set maximum limit. The application deadline for the competitive CDBG program has not been announced.

The first of two required public hearings regarding Mifflin County and on behalf of Armagh, Brown, Derry and Granville Townships, and Lewistown Borough FFY 2023 CDBG program will be held in person at each municipality as follows. These hearings are accessible to individuals with disabilities and/or for persons with limited English proficiency. Items to be discussed include a brief summary of the CDBG program in general, the needs of the County, Armagh, Brown, Derry, and Granville Townships and Lewistown Borough which could potentially be addressed with CDBG funds, and the performance under previously funded CDBG program years.

The following types of activities may be eligible for funding under the CDBG Program: Construction of public facilities and improvements, such as water and sewer facilities, streets, and neighborhood centers; housing rehabilitation; public services that are new or provide quantifiable increases in the delivery of services; removal of architectural barriers; economic development; demolition; and program administration.

Eligible activities must meet one of three national objectives: principally benefit low-to-moderate income persons, prevention or elimination of slums or blight, or meet a need having a particular urgency. At least 70% of the available funding must be used for activities which benefit low and moderate income persons. The proposed activities must benefit at least 51% low-moderate income persons in the service area to qualify as a low-moderate income project.

If the applicant would undertake activities that could result in the displacement of families or individuals, then the applicant is responsible for replacing all low and moderate income housing units that may be demolished or converted. No displacement is anticipated and every effort will be made to avoid or minimize displacement and relocation.

The public is encouraged to attend and participate in the hearing.
